# **Entry requirements**

This TAFE NSW delivered Vocational Education and Training (TVET) course is available for students who are enrolled in school studying for their NSW Board of Studies Higher School Certificate. Students should be in either Year 11 or Year 12.

Students should be at least 16 years old to undertake the work placement for this course as they will be in a work environment with vulnerable people and duty of care requires a substantial level of maturity.

# Learning and Assessment in the Workplace

You will be required to do work placement as part of the assessment of this course.

# The working with children check

Students working with children with a disability may be required by their workplace to sign an 'Applicant declaration and consent' form. Follow this link for more information about the working with children check.

Students outside of NSW will be required to refer to their own state/territory working with children agency.

#### **Criminal Record Check**

Students may be required by their workplace to undertake a Criminal Record Check (CRC) to obtain a National Police Certificate, either through a state or territory police service or through the Australian Federal Police. Please note that this check may take several weeks to complete and students will be required to pay for their own Criminal Record Check.

Gaining the working with children check and criminal record check are the responsibility of the student.

# Overview

This TVET course is a NSW Board of Studies endorsed course.

The Certificate III in Disability addresses work in the community and/or residential facilities under direct or regular supervision within clearly defined organisation guidelines and service plans.

#### These workers:

- Carry out activities to maintain personal care and/or other activities of living for people with a disability
- Carry out activities related to an individualised plan
- Report directly to a supervisor and are not responsible for other workers.

\*NRT – Nationally Recognised Training, this indicates that the course is an accredited course and is nationally recognised.

## **Award**

This qualification is a NSW Board of Studies Non-framework Course. Final results do not count towards the ATAR.
